

# MEETING MINUTES Thursday, 1 June 2023

Zach reports **Lost Turkey Trail Run** is still scheduled for July 29th. We are still waiting for times and courses to be announced. The 147.150 repeater is now mixed mode DMR/Analog. Along with permission, we will have to request it to be placed in Analog only for the weekend. This was brought up with Tom (W3SF) and Kevin (W3XOX) at the May meeting.

John KB3DZF reported that he purchased a Vizio 40" TV for club use, as approved in the May meeting. The total was \$178. This will be brought to field day and can be stored in the van.

Bernie W3DRW purchased the 15-meter bandpass filter as approved in the May meeting. This will also be brought to field day.

**Field Day June 24th and 25th** was discussed. Members volunteered to bring food, cooking equipment, and even radio supplies. Zach will reach out to Giant Eagle to get fried chicken for Saturday. BCARS will also host a VE session during Saturday at 1PM and will try to accommodate any test takers throughout the 2-day event.
