

**VE Session** - KB3DFZ reports that out of 3 test takers, we got 3 brand new Technicians, 2 of which became members. The new amateur radio operators are KC3NZA, KC3NZB, and KC3NZC.

**Pavillion -** as everyone was pleased with our location at Shawnee Park East Beach Pavillion, KC3HKZ put forth that we should book it as early as possible for next year.

WPA ARES - KA3UDR asks that everyone that is not yet signed up for ARES Connect to please do so.

**Repeaters - KB3DFZ** reports that all three antennas and hardline have been replaced on Kinton Knob. Unfortunately, we are having less than satisfactory results from the 440 repeater. The current thinking is that this is a problem in the duplexor. We have a request into Multicomm to come down and service all of our duplexers, as well as check the power output of the radio. Additionally, a request is in to a vendor to give us a quote on a Kennwood TKR-750/751 repeater and matching power supply tuned to our 2M frequency pair.
