

## **OLD BUSINESS**

**Spring Set Exercise**: Steve, KA3UDR brought the club up to date on club preparation, assigning members to work specific repeaters and frequencies, including utilizing the Blue Knob 147.150 repeater. Lloyd K3QNT reported has been in contact with K3HOT from State College Skywarn as well. They can consistently hit our Martin Hill 146.790 repeater better than our Kinton Knob repeaters. We will check in with Skywarn during as well on that repeater.

**Workshop** goes on May 2nd. BCARS will keep it on the calendar, however, due to the COVID-19 pandemic and ongoing "Stay At Home" orders until April 30th, it is very likely that this event will need to be rescheduled. Similarly, the VE session on May 23rd may need to be postponed. BCARS may look into providing small-session exams with the minimal amount of required people (3 VEs plus any test takers).

## **NEW BUSINESS**
